

WISE COUNTY TEEN COURT RELEASE OF LIABILITY

THE STATE OF TEXAS COUNTY OF WISE

Parent and/or Legal Guardian of [redacted], a minor, do hereby FOREVER RELEASE, HOLD HARMLESS, INDEMNIFY AND AGREE TO DEFEND Wise County, its officers, agents, servants, employees, and persons for whom community service is specifically provided, from any and all claims, demands, liability, suits, actions or causes of action which I, individually or as a parent and/or guardian of above said minor, have against Wise County, its officers, agents, servants and employees, and or persons for whom community service is specifically provided, from property loss or damage, and/or personal injury including death, sustained by said minor, and particularly for any and all medical or hospital expenses, doctor bills, nurses expenses, drugs or any other damages of any kind or character and any other type of damage which said minor may hereinafter have, arising out of, resulting or in any way connected with the participation by said minor in the Wise County Teen Court, Inc., Program whether or not caused by the alleged negligence of Wise County, its officers, agents, servants, employees, and the Junior League of Wise County, and persons for whom community service is specifically provided.

It is understood and agreed that the minor will perform solely as an individual on a voluntary basis and not as an employee, contractor, or agent of Wise County, its employees or officials, Wise County Municipal Court, the Junior league of Wise County, or persons for whom community service is specifically provided.

I hereby assume all responsibility and liability for such damages or injuries sustained by said minor.

I have read this Release of Liability and fully understand its terms and conditions. I have not been influenced to any extent whatsoever by any representation or statements not contained in this Agreement. I hereby acknowledge that the above named minor has my permission and consent to participate in Wise County Teen Court, Inc. Program and that this release is given in consideration of Wise County allowing said minor to participate in Wise County Teen Court, Program.

PARENTAL CONSENT FORM

We/I, the undersigned parent(s) / guardian(s) for [redacted] do hereby grant permission for said juvenile to participate in the Community Service Program. We/I understand that the total work hours will be determined by the court and that the daily hours will not exceed those of a regular working day (8) hours without prior consent. We/I understand that the type of work involved in the program consists of light labor and manual chores such as painting, yard work, raking, cleaning, planting, filing, typing, and landscaping. At no time will our/my child be subject to unreasonable risks. He/she will also be properly supervised.

We/I further understand that [redacted] is not an employee of Teen Court or of the assigned Community Service Program work site. Neither Teen Court nor the work site will be liable for any injuries or accidents that may occur to our/my child during the course of the program and that we/I as parent(s) are assuming all liability for any such injuries. We/I, the undersigned parent(s) assume responsibility for transportation to and from the work site.

We/I agree to all of the conditions as set forth above, including, but without limitation, releasing all public and private employees involved in the program from any and all liability, which may arise out of our/my child's participation in the program.
